GREETINGS;

In the name of the State of Maine, you are hereby required to notify and warn the voters of the Town of Sedgwick, in said County, qualified by law to vote in town affairs, to meet at the Sedgwick Town House, in said Town on Friday, the 6th day of March 2009 A.D. at 12:45 p.m., then and there to act on the following articles:

ARTICLES:

- 1. To choose a Moderator to preside over said meeting.
- 2. Election by secret ballot of the following officials: 3rd Selectman, Assessor and Overseer of the Poor for three years; Tax Collector for three years; School Committee, one member for one year, two members for three years

Polls open at 1 p.m. and close at 6 p.m. on March 6, 2009. The Town Meeting will reconvene at the Sedgwick Town House on Saturday, March 7, 2009 at 9 a.m. to act on the remaining articles.

SECOND SESSION

3. To see if the Town will vote to increase the property tax levy limit of \$243,180.27 established for the Town of Sedgwick by state law in the event that the municipal budget approved in the following articles will result in a tax commitment that exceeds that property tax levy limit.

- 4. To see if the town will vote to raise and/or appropriate \$2,000 for the research, development and maintenance of the town's Public Right of Way Access Points.

 The budget committee recommends raising \$2,000.
- To see if the Town will vote to raise and/or appropriate \$500 for the cleaning, sorting and stabilizing of old Town Records.
 The budget committee recommends raising \$500.
- 6. To see if the Town will vote to continue to set October 31 as the date after which a rate of 8 percent per annum interest on unpaid taxes will be charged.

Explanation: The Town's contribution to the total cost of funding public education from kindergarten to grade 12 as described in the Essential Programs and Services Funding Act is the amount of money determined by state law to be the minimum amount (\$1,342,991) that the town must raise in order to receive the estimated amount (\$40,000) of state dollars.

The School Committee gives the following reasons for exceeding the State's Essential Programs and Services allocation model.

Reasons: The additional local fund request exceeds the EPS funding model because the school spends more per pupil on regular education, special education, transportation, student and staff support, administration and facilities maintenance than the EPS formula recognizes. The state's EPS funding model isn't an equitable way to judge the budget for a small school.

Explanation: The additional local funds are those locally raised funds over and above the town's local contribution to the total cost of funding public education from kindergarten to grade 12 as described in the Essential Programs and Services Funding Act that will help achieve the school's budget for

educational programs.
