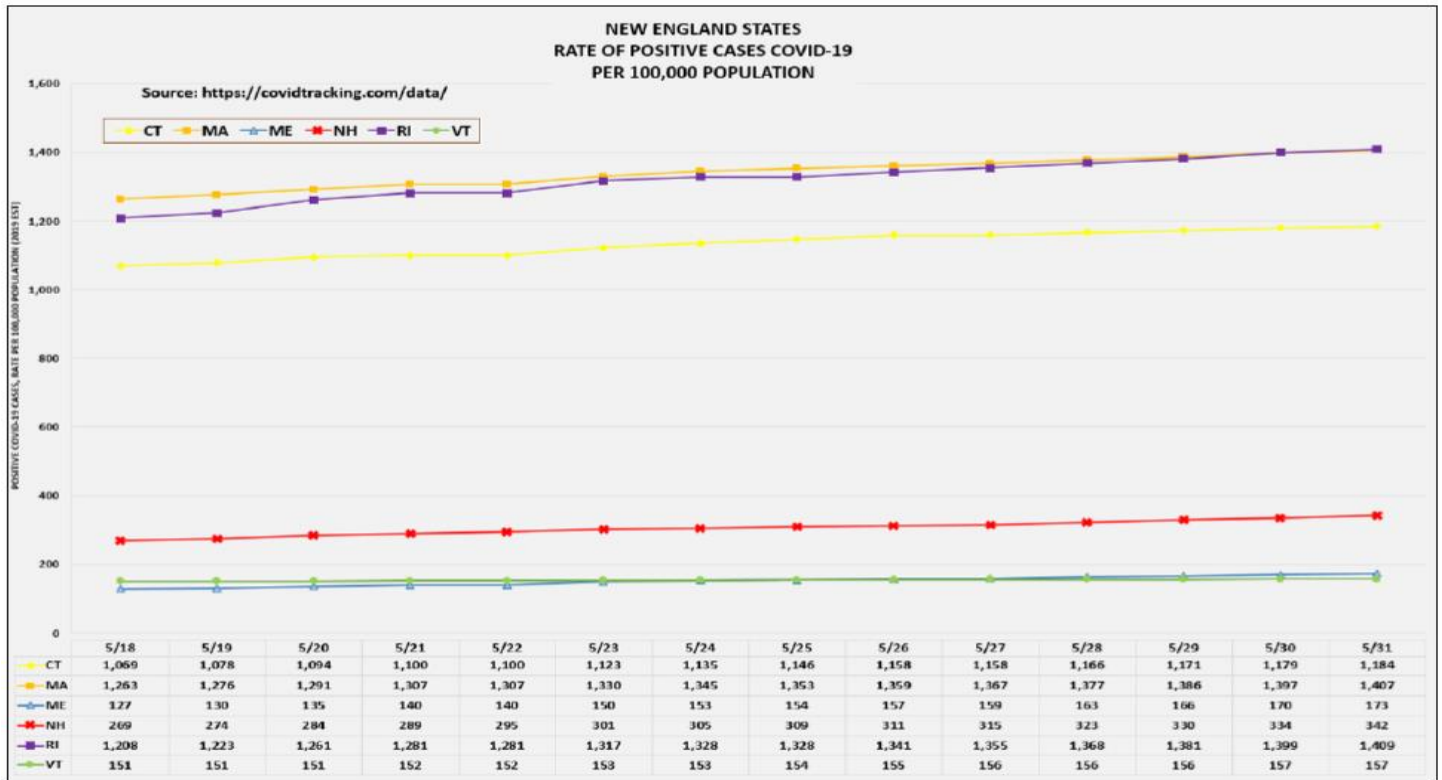

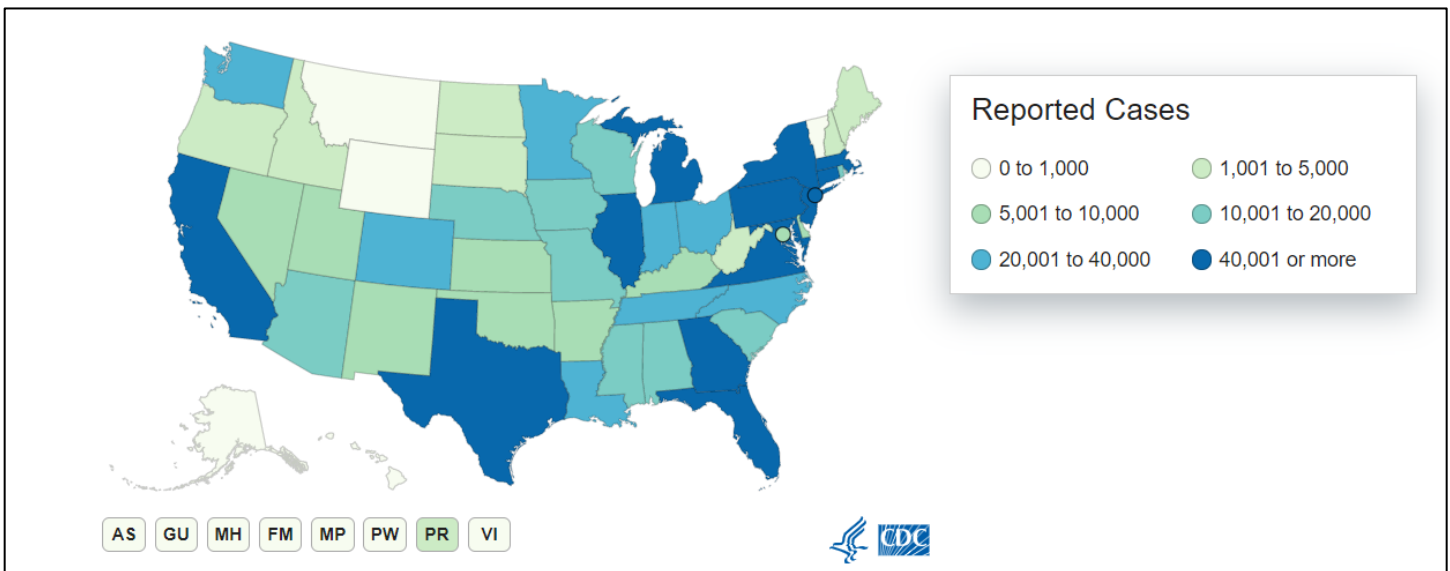


(U) New England States Rate of Positive Cases COVID-19 Per 100,000 Population:
