

Dear Sedgwick Neighbors:

It continues to be an honor to serve you in the Maine House of Representatives. I am proud to advocate for our community in Augusta.

Over the last year, I've increasingly felt the pressure, and heard from many neighbors who have worked hard to get ahead, that rising costs are stretching budgets to the max. Paychecks are not going as far as they used to and it's becoming more difficult to build healthy, prosperous lives here in Maine – and throughout the country.

In 2025, the Legislature put working families first by passing measures to protect critical investments in health care, food security, education, child care and housing. But I know this is just a drop in the bucket compared to rapidly increasing costs. This year, I will continue fighting for real solutions to help address the problems facing families here in our district and across the state, including tackling the rising costs of housing, health care, child care and utilities.

Dear Friends,

I hope this letter finds you well.

As you likely know, my time in Congress will come to an end in January 2027, after which I'll return to my family and my life as a private citizen. In other words, this is my final town letter.

My time as your representative has included a fair share of ups and downs, but one thing that never changed was the pride I brought with me to represent your community and all the others across Maine's 2nd Congressional District.

Maine has been home for my entire life. And while serving in Congress has meant a lot of time in Washington, D.C., I've tried my best to stay connected to the people, places and values that made me who I am.

Growing up in Leeds, I learned the value of hard work and community. When I enlisted in the U.S. Marines, a decision driven by the commitment to service and patriotism instilled in me by the people and places that raised me, I learned a lot about sacrifice and leadership. After my time in the military, I settled in Lewiston and served my city in the Maine State House, where I got a crash course in what representation really meant: listening, understanding, and fighting to make life better for the people and families who'd placed their trust in me.

I brought these values and experiences with me to Congress, and tried to live up to them every day I have served.

I share all this not because my story is special or my values unique, but because I know that it is not.

It's fair to say that I've worked in one way or another with most every community in the District. Together, we've reduced pressure on property taxes by securing congressional funds for local projects. We've passed laws to support Maine's heritage industries and small businesses. And my

## **Greetings Everyone**

Another year has come and gone. Several new items have come up this past year. We have a Glampground in Sargentville which was not an easy thing for the planning board and select board to work on. It was a new and different project for all of us to deal with. Many ups and downs which we all have learned how to handle through this experience.

This year we also streamlined many things in the office. We did a big house cleaning which gave us much more useful space. We were able to update a couple desks and cupboards to help serve our townspeople easier. We are working on continued support to keep effective hours at the office. Our parking area was also blacktopped this past year. It is much easier to remove the snow and walkway making it easier for everyone to park and walk up to the office stairs.

Our accounting system is in a much better place now through TRIO. Checks can be written in the system and it will go to the proper account. It certainly helps to know what money went where and how much. Our current Treasurer, Amy Dunn, has worked very hard this last year to get everything going in the new system. Thank you Amy.

There was a new property assessment done by factoring a new ratio. It brought us much better numbers for the state balance. We have to maintain a certain ratio balance or we could be fined by the state if it is too low and could lose our homestead exemption allowance. Some property taxes went up and most others went down. It has put us in balance with the state ratio.

Our town finally has flags down Main Street thanks to Mr. Boardman and his work with one of the Veterans Organizations. Many people were surprised but we had an offer we could not refuse since they were free. We are very pleased to see the flags flying from Memorial Day through September. Thank you again Mr. Boardman.

There are many, many little things that have come up in our Select Board Meetings. We finally have people attending in person. Oftentimes things come up we know nothing about and are able to take care of it immediately. We welcome everyone to attend at least once.

Changes have happened good and bad but overall, this has been a good year. Thank you Paul Carter for the many, many years of service to the town. You will not be forgotten. Thank you Lyndsey Dow for your dedicated service to our community and the help you have given our office and citizens these past few years. # Town CEO Report

## *Calendar year 2025*

During the past year, the "Glampground" project at Caterpillar Hill drew a lot of interest, sparking lots of conversation and questions during public hearings and from beginning to end of the process. The Planning Board did a stellar job navigating the process including the review and submission of the initial application, and by the end the site plan review was granted and a D.E.P permit-by-rule for the first acre of the grounds.

A number of other projects are carrying over into the new year. There are four different ongoing shorefront repairs involving the D.E.P along the Reach. Some new work was not completed before the deadline (April 1st) will be picked up by the Assessor's Agent in the new fiscal year.

The Hancock County Planning Commission is working a new housing plan for the area but towns like Sedgwick, Brooklin, Brooksville; under 4,000 population are not considered eligible for the program participation due to their size. As before, area towns are also exempt from the otherwise mandatory Maine State Building Code referred to as "M.U.B.E.C"

As always, we are answering lots of questions about Land Use for those with house and or site questions. We remain available to all on a 24/7 basis.

## SEDGWICK POPULATION

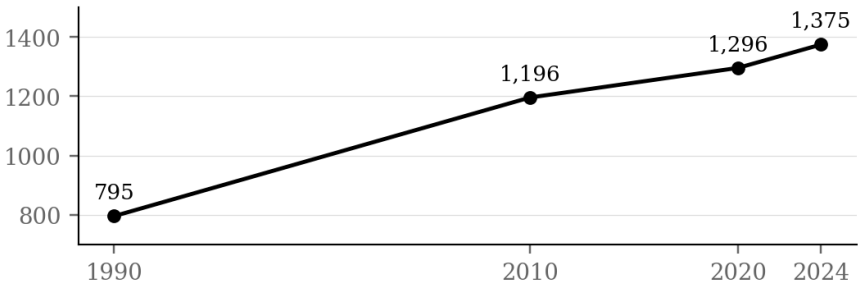


Figure 1. Decennial U.S. Census counts plus the 2024 town estimate. Sedgwick has grown roughly 73% since 1990.

# Planning Board Report

## *Calendar year 2025*

The Planning Board met regularly on the second Tuesday of each month throughout 2025. Meetings were previously held at 7:00 p.m. and now begin at 5:00 p.m.

Planning Board Members: Jon Woodward (Chair); David Carter; Dick Doane; Drew Allen; Jerry Wetterskog; and Bill Flagg (Alt). Secretary: Lyndsey Dow.

The Board would like to congratulate the Comprehensive Plan Committee on the successful completion and adoption of the Town's Comprehensive Plan and thank them for their countless hours of work on the project. Several informational meetings were held throughout the process, followed by a Special Town Meeting where the voters approved the plan.

There were several permits presented to the Board during the year, including Caleb Scott's proposed campground, Ferncrest Acadia. The project generated considerable discussion and public interest, with opinions both in favor of and opposed to the proposal. Ultimately, Mr. Scott's application was found to be in compliance with the Town's Site Plan Review Ordinance and was approved in May 2025 with a Maine DEP Permit-by-Rule.

Duane Ford, our Code Enforcement Officer, continues to work closely with the Planning Board throughout the year. Duane regularly brings forward new applications for review and discussion at monthly meetings. He also continues to work with the Maine Department of Environmental Protection on shoreland erosion issues affecting many properties following recent winter storms.

Barry Duffy, our Second Selectman, took over attendance at monthly meetings following Colby Pert's departure. Lyndsey Dow joined the Board as Secretary, assisting with monthly agendas, meeting notices, and preparation of meeting minutes.

# Comprehensive Plan Committee Report

*Calendar year 2025*

Sedgwick's creation of its first comprehensive plan began in 1974, followed by updates in 1980 and 1993. Beginning in the spring of 2023, the current Comprehensive Plan Committee (CPC) worked diligently to craft a new plan that reflects our community's vision for the future.

In April 2025, the CPC submitted the updated Plan to the Maine Municipal Planning Assistance (MPA) Department for review and approval. With input and valuable feedback from state agencies including Transportation, Inland Fisheries and Wildlife, Health and Human Services, Economic Development, and Marine Resources, the MPA approved the Plan in June 2025. The CPC incorporated many of the suggestions and included all agency comments in the Plan's appendix for full transparency.

To keep residents informed, the Plan was posted on the Sedgwick website, and an informational meeting was held on August 26 at the Sedgwick Fire Station. A special town meeting followed on September 9, where residents voted to approve the Plan – an important milestone for our town.

Thanks to the dedication of committee members, the CPC saved nearly \$8,000 during this process. We extend heartfelt thanks to the Sedgwick Planning Board, Sedgwick Select Board, Town Clerk, CEO, and, most importantly, our residents for their support and participation in shaping Sedgwick's future.

# Budget Committee Report

*Calendar year 2025*

Our committee a group of volunteers and is tasked with reviewing various budgets within the town of Sedgwick. It is a good idea to have some residents look over our town finances to see if they look reasonable. Our committee makes recommendations but has no authority to make final decisions, that falls to voters at town meeting.

We reviewed nonprofit requests to the town to see what their relevance to the town is. They all provide services to residents of the town. We ask to see what the services are, how many Sedgwick residents are served, and the value of those services. We also request a financial statement showing income and expenses of the organization. All these services are also funded from several or many other sources. Nonprofit organizations with requests over \$2,000 are asked to meet with us to present themselves and to answer questions from the committee. Requests must be made by the end of December to be considered.

The PAC, ambulance service, is our biggest request in this area and we spent almost an hour and a half asking them questions and listening to their answers. The income and expenses are complex and depend on many factors including local hospitals, insurance (or a lack thereof), and government programs. It is an essential service we do not want to be without. The organization has been cited as an example to other towns for its efficiency in the small-town environment that we have – which is encouraging.

Community Action in Aroostook, Washington and Hancock Counties – formerly Downeast Community Partners – provided a lot of extra information due to the financial problems that DCP has had. You may have seen some of the newspaper articles about them. Our committee was convinced that despite all the problems, our Sedgwick residents were receiving services far in excess to funds requested. Our support will help Friendship Cottage and other services continue, and will encourage matching funds from State and Federal programs.

We also review town budgets after the Selectmen have designated their needs. Town budgets are not like budgets individuals might have. Individuals have some source of income and try to spend within that budget. The town proposes what funds it needs to carry on its business and that is voted on by the residents at the town meeting.

Then our taxes are adjusted to meet that number. Sedgwick tax revenue is not as high as many of its neighboring towns that have more shorefront and therefore more income on a per-resident basis.

The largest expense of the town is the school budget. Our committee members are not school board members and usually play catch-up on what is going on and the expenses associated with that. The per-pupil cost of education in our K-8 program is more expensive than that of local private schools or all the local high schools. The student enrollment is low and economy of scale is not possible. We have State-mandated expenses without equal State funding. The Blue Hill peninsula has several school unions, superintendents, and principals to oversee a relatively low student population — a population predicted to decrease in the near future. We are facing a perfect storm: our per-student cost will go up.

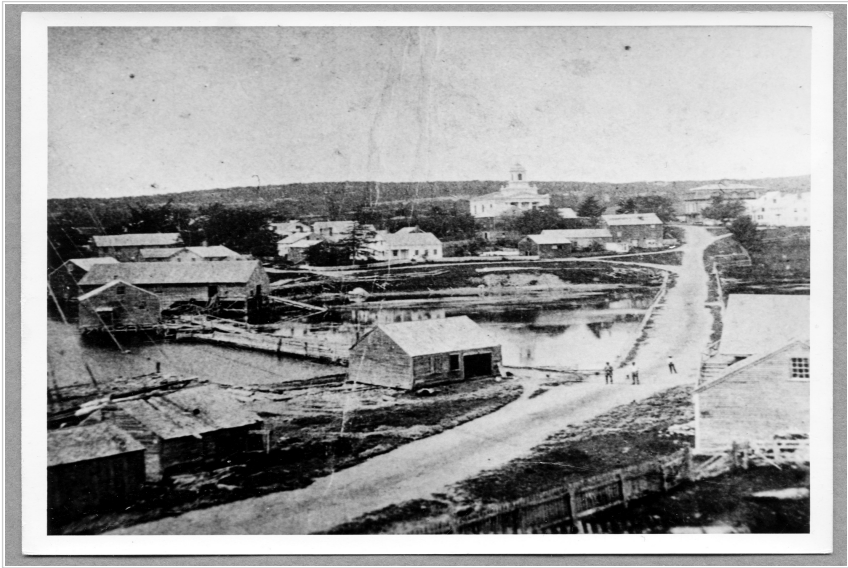
If it were possible to join efforts with other towns, we could probably create more efficiencies and bring our per-student cost down. Lower expenses do not equal lower quality education and could conceivably improve that quality. Historically the peninsula towns have not been great at joining together to help each other in this area. We suggest that people tackle school affordability issues and look at all the ideas we can come up with.

2025 proved to continue to be another very busy year for the department. We were paged to a number of incidents with the Deer Isle and Stonington Fire Departments. This agreement among the three communities continues to be mutually beneficial in providing fire protection. The Volunteers also spent many hours at various meetings, monthly dept. meetings; committee meetings; Hancock County Firefighters Association meetings; as well as attending fire prevention activities, fundraising activities and work sessions.

The department wishes to thank the residents, town officials, and taxpayers for your continued support, which is essential to the future of the department. We will continue to strive for excellence in everything we do. In 2025, thanks to ongoing support from taxpayers and fundraising efforts, we were able to raise enough money to purchase a set of air bags and rescue struts. After a long wait, we finally received the equipment. We will continue to seek and apply for any and all grant funding that becomes available, and look forward to fundraisers such as the annual car show, which has been and continues to be a huge success.

Remember, to reach any emergency services, you must dial 911. The E911 system is set up to give the dispatchers the exact location of an emergency call, thus saving emergency responders critical time by providing better directions to the emergency. Be prepared to answer any questions that the dispatcher may ask. This information is critical for a timely and correct response to the emergency. Please answer the questions asked and stay on the line until the dispatcher tells you to hang up.

Fire safety needs to be practiced in each and every home. Smoke detectors should be located on each level of your home. They need to be checked, and tested regularly and should be cleaned and batteries replaced twice a year. Smoke detectors should be replaced every 10 years. Develop home fire drills, preplan your escape routes and practice them regularly. Establish a safe meeting area outside the building. If you have any questions, contact the fire department.

Open burning permits are only available online at [Maine Open Burn Permit](#). There is no charge for the permit and it is valid for 24 hours. A permit is required for any outdoor burning.

I want to thank our volunteer firefighters for their dedicated service to the Town of Sedgwick and surrounding communities. Our firefighters give a tremendous amount of time and many times risk their lives to protect our citizens and property. Our firefighters do their job for the pride and satisfaction of providing a great service to our town. They are a very dedicated group of people. We are very lucky to have them.

**PENINSULA AMBULANCE CORPS  
2025 Report to the Towns**

The economy continued to create challenges for us during 2025. Inflation has continued to increase the cost of providing services. In addition, it has increased the cost of our 2027 ambulance delivery. Economic stressors and changes to the Affordable Care Act on individuals have made it difficult for many patients to pay their portion of the ambulance bills.

We saw an increase in call volume, setting new records in total call volume and patient transport call volume. We had a 1.8% increase in total call volume and 6.7% increase in patient transport volume. This resulted in increased income but also resulted in higher use of fuel and supplies.

Totals by town are displayed in the chart below. We set a record call volume in 2025.

We were able to extend our coverage hours by adding a second ambulance during the 7pm to 11pm period for higher call volume days. This resulted in 25 fewer calls given to mutual aid, higher call volume and increased revenue. We plan to continue this in 2026 and, if staffing allows, provide it on more days of the week.

Our largest payor in 2025 was commercial insurance accounting for 42.7% of our total income from patient transports. Our 2025 payor mix is in the following table.

It is important to note that most payers do not pay the total amount billed. Medicare and Mainecare have rates set by the government. Medicare pays \$0.27 for every \$1 billed and Mainecare pays \$0.25 for every \$1 billed. In addition, self-pay (patients paying) has dropped significantly in the last few years. 2025 saw patients paying only \$0.06 for every \$1 billed.

We continue to see a large number of our calls being interfacility transports. 2025 had 45% of our transports being interfacility. With Blue Hill Hospital being a critical access hospital with limited inpatient and ED beds which means that PAC conducts more transports from our Peninsula to Maine Coast and Eastern Maine hospitals. Movement of patients between hospitals is an important function of EMS. It gets patients to the definitive care they require and frees up local hospital needs for new patients. In addition, the income from interfacility transports helps keep town contributions as low as possible.

We are proud of our eight full-time and sixteen part-time and per-diem staff—the Paramedics and EMTs who make the program work. They have completed 1851 calls in the last year and have been steadfast during these trying times. We continue to provide staff with continuing education for federal and state mandated classes. We believe the morale of our staff is high and we know that they provide an invaluable service to PAC's seven communities on the Blue Hill Peninsula. EMS staffing is an issue nationwide. We continue to explore recruitment and retention solutions. Our three ambulances allow us to maintain our staffing model of two on duty ambulances with a spare to use when the others need service. This also allows us to staff the third ambulance for local events, such as the Blue Hill Fair, and at times of peak call volume when we utilize management to staff the third ambulance. This allows us to respond to more calls. Our goal for 2026 is to increase coverage in the 7pm to 11pm period to match the increasing call volume.

We cut our deficit in three ways: with the support of our town governments, by individual donations to our annual appeal, and by using unpaid volunteer board members to accomplish many tasks.

This year we are asking for \$25.25 per capita (from the 2020 census) for the operating budget (an increase of \$0.50) and \$10.50 (an increase of \$2.50) for the ambulance reserve fund. This is a total of \$35.75. We are scheduled for an ambulance purchase in 2027 to replace our oldest ambulance which by 2027 will have greater than 200,000 thousand miles on it. Last year we increased our ambulance reserve assessment in response to a 45% increase in projected purchase cost. We received an update in 2025 from our vendor that actual cost continues to increase and they are now predicting an additional \$35,500 will be required. This requires an increase in the ambulance replacement fund contribution from the towns with the 2026 budget.

We continue to need additional staff as call volumes increase. We must pay our people what they are worth if we are to keep them. Potential new Staff must balance their remarkable dedication to an essential calling with their need to feed their families, pay for heating and keep a roof over their heads. This year's requested increase in operating funds will support staff compensation.

Staff and ambulances are the visible aspects of PAC, but community loyalty and the funds provided by the towns are its lifeblood. Our annual appeal to the public provides an essential and remarkably consistent source of support, but in order to close the remaining gap we rely on the good will of Town

### Dear Sedgwick Students, Families, and Community Members,

It is a privilege to present my first annual report as your Superintendent. Over the course of this year, I have had the opportunity to see firsthand the strength of this school community and its deep commitment to students. Sedgwick Elementary School continues to be a place where children are known, valued, and encouraged to grow academically, socially, and emotionally. I am grateful for the support shown to our students each day.

As we look ahead to the 2026–2027 school year, the proposed budget reflects our continued commitment to strong educational programming while planning responsibly for the future.

### Budget Vision: Investing in Our Future

The 2026–2027 budget is guided by four priorities designed to strengthen educational opportunities, support students and staff, improve facilities, and ensure long-term stability.

First, we are committed to strengthening community connections and supporting enrollment efforts. Funds have been allocated for community events, outreach materials, and partnerships with local organizations that help connect families to the school. A small discretionary fund will also support community-based projects, including garden initiatives that enhance student learning and engagement.

Second, this budget prioritizes support for staff and students. We will maintain strong staffing levels while continuing to invest in professional development, expanded special education programming, and strengthened Multi-Tiered Systems of Support (MTSS) interventions. Additional funding supports field trips, Science Technology Engineering Mathematics (STEM) and arts programming, outdoor learning opportunities, and year-round garden care that enriches the student experience.

We are also focused on improving the appearance, safety, and functionality of the school campus. Planned investments include capital improvements, exterior upgrades, and safety enhancements. In partnership with project managers and through the School Revolving Renovation Fund (SRRF) process, we will begin developing a comprehensive five-year facilities plan to guide future maintenance and improvement projects.

Finally, this budget reflects our commitment to long-term financial stability. We continue to prioritize careful spending while building reserves to prepare for unexpected costs and future needs, ensuring resources remain focused on supporting students.

### Progress and Accomplishments

The period from July 2025 through February 2026 has been marked by meaningful progress across operations, safety, and instructional leadership.

The district was approved through the Maine Bus Purchasing Program for the purchase of a 35-passenger diesel -powered bus. Owning a district vehicle positions us to reduce long-term mileage costs while providing safe, reliable transportation.

Throughout the year, the Policy Committee remained highly engaged, carefully reviewing and updating policies to ensure the Brooklin School remains compliant with changes to the Maine Revised Statutes and aligned with best practices.

Student health and wellness were enhanced through the generosity of the Blue Hill Congregational Church, whose donation allowed us to install a hook-up for a moving dental clinic. This partnership enables students to receive on-site cleanings for sealants, reducing barriers to essential preventative care.

#### **Facilities and Safety**

Maintaining a safe, well-functioning school facility continues to be a top priority. We are partnering with Energy Efficient Investments (EEI) to create a long-range capital plan, complete energy audits, and phase infrastructure upgrades to our school.

Following a site assessment conducted by the Maine School Safety Center, we updated and strengthened our Emergency Operations Plan. To ensure this comprehensive safety guide is practical and accessible during emergencies, we met with our local first responders to be sure we are all on the same page when it matters most.

#### **Financial Overview**

The proposed 2026-2027 expenditure budget totals \$3,566,782.87, representing a 4.87% increase from the previous year.

The majority of funding is derived from local contributions totaling \$3,218,784.25, while state education subsidy provides \$346,998.62, including an additional one-time funding allocation.

Principal's Report - 2026**

The 2025-2026 school year is proving to be a very good year at Sedgwick Elementary School. We retained most of our staff with only a new guidance counselor, Mrs. Chermak, and 2 new ed-techs joining our staff. Our commitment to Project-Based Learning and our student showcases, where students present their hard work to families and the community, has been a great success. We are also proud of our student-led parent conferences,

Our classroom projects not only help students master the standards in our current curriculum but also help them to incorporate much-needed 21st-century skills. Like most schools across the country, we are using a Multi-Tiered System of Support (MTSS) to engage our students, fill gaps, and enrich their learning. We look at the classroom data and testing results during our Professional Learning Community (PLC) time to help identify the needs of individual students.

We are pleased this year to take part in BARR training (Building Assets & Reducing Risk). This program is designed to address all students. BARR is a widely implemented K-12 educational model designed to improve student outcomes, specifically raising test scores, increasing engagement, and reducing failures by fostering strong, intentional relationships between staff and students and using real-time data to drive instruction. One of the areas we are specifically targeting is attendance. Our staff has been implementing the program and is already excited about the benefits we are seeing in the school.

Last summer, we again conducted summer school four days a week for four weeks. About one-third of the enrolled students participated. We offer enrichment in math and Language Arts, as well as swimming lessons, outdoor activities, and enrichment activities, such as arts & crafts and coding. The summer school program and the after-school program together are providing enrichment opportunities for over half of our students throughout the year.

This year, we have implemented our part-time librarian. The library looks great and is being used on a more regular basis. We still have some volunteer help, as it is quite a task to keep up with all the taking out and returning of books.

We have provided field trips to concerts, Camp Kieve, the Gulf of Maine Research Institute, the Common Ground Fair, and many local hikes and venues. We've also had the opportunity to see a couple of productions at The REACH theater at DISES and the Grand Theater in Ellsworth. These activities reinforce the importance of lifelong learning and show students that learning happens outside of the classroom as well.

We are pleased to offer a range of extracurricular opportunities at SES. Sedgwick students are having a great time playing soccer and basketball, and learning new skills. Our teams have demonstrated great sportsmanship while competing with other area schools. We also offer a variety of different extracurricular opportunities such as Lego Robotics, writing groups, and coding. Students are working on their first theatrical production, "Robin Hood and the Wedding of Doom," with a show planned for the spring.

I have been meeting with the maintenance committee to prioritize projects that are needed around the school. We hope to repave the parking lot and work on the building trim and grounds during the summer break. We are still participating in the MLTI program that allows us to provide one-to-one devices to enhance student learning.

Sedgwick Elementary School's Science, Technology, Engineering, Art, and Math (STEAM) Program continues to help teachers work together with our STEAM Instructor. Delving into topics such as composting, electricity, musical instruments, and engineering topics like designing cardboard sleds and other projects.

Overall, the 2025–2026 school year has been a strong and positive year for Sedgwick Elementary School. Through the dedication of our staff, the engagement of our students, and the support of our families and community, we continue to provide meaningful, well-rounded learning experiences for all students. Our focus on Project-Based Learning, MTSS, STEAM, enrichment opportunities, and relationship-centered initiatives like BARR reflects our commitment to meeting both the academic and social-emotional needs of our students. As we look ahead, we remain focused on continuous improvement, maintaining high expectations, and ensuring Sedgwick Elementary School remains a place where students feel supported, challenged, and excited to learn.

## Financial Highlights

GSA has made measurable progress in strengthening its financial position. For the fiscal year ending June 30, 2025, GSA operated with a balanced budget and a modest surplus, reflecting disciplined budgeting, improved cash flow, and sustained community support.

### Key Financial Highlights from Fiscal Year 2025:

- **Total operating revenue:** \$5.4 million, derived primarily from tuition and fees, town-approved supplemental tuition, philanthropy, and endowment support
- **Total operating expenses:** \$5.3 million, with the majority directed toward educational programs and direct student support
- **Operating surplus:** \$90,261, marking continued progress after several challenging fiscal years
- **Cash and cash equivalents:** \$1.1 million at year's end, reflecting improved liquidity
- **Total net assets:** \$14.2 million, including an endowment of just over \$11 million supporting long-term sustainability and financial aid

### Revenue Breakdown (FY 2025):

Total operating revenues of \$5,416,097 came from:

- **Tuition and fees:** \$4,109,930 (75.9%) from sending towns, special education tuition, and related sources
- **Earned revenues (including food service):** \$194,749 (3.6% of total)
- **Charitable gifts and pledges:** \$1,276,765 (23.6%)
- **Government grants:** \$37,474 (0.7%)
- **Endowment appropriation:** \$379,814 (not reported as earned revenue, simply a release of endowment funds)
- **Offset by Loss on Disposal of property & equipment** -\$202,821 (-3.8%)

### Expense Breakdown (FY 2025):

Total operating expenses of \$5,325,836 were allocated as follows:

- **Educational programs:** \$4,036,301 (75.8%) for faculty/staff compensation, classroom instruction, academic supports, and student services
- **Management and general operations:** \$866,156 (16.3%)
- **Auxiliary services (food service):** \$207,593 (3.9%)
- **Advancement and fundraising:** \$215,786 (4.0%)

The fiscal year concluded with a positive operating margin of 1.7%, reflecting disciplined budgeting, stable enrollment revenue, and careful cost management while maintaining strong educational programming.

In alignment with our commitment to fiscal responsibility, the Board of Trustees has voted to reduce the supplemental tuition assessment by 10 percent beginning next year, followed by additional 10 percent reductions in each of the subsequent two years. This planned three-year reduction reflects the Board and school leadership's intent to balance educational quality with sound financial practices.

As we plan for GSA's future, we recognize that long-term sustainability requires open dialogue with our communities. In the coming months, GSA leadership and board members will be engaging in measured, one-on-one conversations with residents, town officials, and school committee members about the possibility of town enrollment contracts in the not-too-distant future.

These conversations are exploratory in nature and designed to listen, learn, and understand each town's unique perspective. We believe that decisions about public education benefit from thoughtful relationship-building and transparent information-sharing. No decisions have been made, and any potential changes would only move forward with broad community understanding and support.

We welcome questions, concerns, and ideas from community members throughout this process. ## Blue Hill Public Library - Municipal Report for 2025

On behalf of the Blue Hill Public Library staff, board of directors, and Friends, I write to thank you for your ongoing support for the library and to provide a summary of library activities and developments in 2025.

### Public Services

From a public services perspective, 2025 was historic and rewarding. The library provided more events and programs than ever before, setting a new record with more than 12,000 patrons attending these events. Whether book groups, teen activities, lectures, movies, storytimes, playgroups, there was something for everyone at BHPL. Staff also answered more reference and technology questions than ever before, and the library added new electronic resources to meet the growing demand.

Over the 300 service days in 2025 the library:

- Loaned 107,301 physical and digital items (books, audiobooks, movies, etc.). We observed an increase of 0.4% in the use of physical items, while use of the digital library surged with a 74.7% increase over last year. The increase was a result of the addition of Kanopy, our new streaming service, as well as an increase in e-book, e-audiobook, and e-magazine usage (the latter a 129% jump).
- Answered 6,330 reference questions, 2,322 more than 2024 and over 4,000 more than the 2019 pre-pandemic level. Library staff also provided 5,914 technology help sessions to patrons, a 50.4% growth over 2024 and a 325% increase over the 2019 level. Questions are answered in person, by phone and via email.
- Welcomed 95,797 patron visits; approximately equal to our 2024 visitor total and registered 655 people for library cards.
- Hosted 24,238 WiFi sessions, a 28.6% growth from 2024's total, while use of the library computers (4,255 sessions) also increased by 25%.
- Sponsored 714 events that attracted 12,453 attendees. This historic attendance marks the first time that the library hosted more than 12,000 participants in a year. This 2025 attendance is 16% greater than the 2024 and is driven largely by the popularity of youth programming. Kudos to the youth services staff for their hard work.
- Community-sponsored events (meetings, etc. that take place at BHPL but are not hosted by the library) totaled 589, with an attendance estimate of 5,297. The number of events was down by 10, however, attendance increased 32% over 2024.

The library's early childhood offerings increased significantly in 2025. Thanks to targeted private support for what we are calling our "Free Range Librarian," we increased services to our youngest patrons, adding special events at the library, traveling storyhours at local childcare centers, and special playgroups at the Lawrence Family Fitness Center and YMCA. Additionally, BHPL is certified as a "Family Place Library" and we continue to host seasonal Family Place workshops that support parents/caregivers and their children with education and community. We believe that this

investment in early childhood pays dividends later in life and are pleased to be able to bring these efforts to our community.

Of course, the library serves people of all ages, not just the very young. A boisterous group of tweens and teens spends after-school hours upstairs in the teen area and some take part in our Anime Club, the YA Café, Skein Stitches fiber arts club, etc. BHPL also offers family-oriented programs, like after-school chess, playgroup and more. And we haven't forgotten about our adult visitors either. We host weekly meet-ups for knitters, chess players, and those who enjoy discussing current events, along with a plethora of author visits, documentary screenings, art classes and nature-based programs. There is always something new to try at the library.

## **Campus Planning**

Many of you know that BHPL has purchased property that is adjacent to the library with the ultimate goal of expanding our grounds, increasing parking and adding amenities with a focus on sustainability to better serve our patrons. As of this writing, we are in the planning process and intend to share the results of our efforts during 2026. Please stay tuned to the library newsletter and media outlets for updates.

## **Library Funding**

The library's operating income comes from three main sources: municipal funding (now 14% of the total, most of which is from Blue Hill, with additional funds from Penobscot, Sedgwick and Surry), annual fundraising (39%, derived from events, the annual fund, etc.) and operating income (47%, primarily from the library's endowment funds). For 2026, the library's operating budget is \$890,781 which provides the peninsula with 55 hours of weekly service hours over 6 days.

Our active Friends of the Library group provides funding for a significant portion of the library's lectures, workshops, and other public events for all ages, as well as items and services not provided by the operating budget, including performances, movies, and circulating materials. While we think of these things as "extras," BHPL would be a very different library without their contributions. All told, the Friends gave more than \$24,000 to the library in 2025 and has already provided \$20,600 for 2026.

## Blue Hill Heritage Trust

Blue Hill Heritage Trust's mission is, "to lead in conserving land, water, and wildlife habitat on the greater Blue Hill Peninsula. To teach and practice a stewardship ethic. To promote ecological, economic, and community health for this and future generations." Much of our work is future-focused, looking to protect and enhance the long-term health of both land and people, and Blue Hill Heritage Trust is committed to both conserving land in our towns and serving those communities.

In 2024 we conserved over 170 acres on the peninsula. About half of this was focused on habitat protection, with one project in Blue Hill and a second adjacent to our Wight's Pond focus area in Penobscot, while the other half prioritized recreational opportunities across the peninsula.

We are still in the process of formalizing an accessible trail at our Ferry Landing Road parcel. Our primary focus here is to keep a large portion of this 15.3-acre parcel wild for the animals and plants, but to have a nice educational and accessible trail for young and old. As we see more development on the peninsula, these wild areas and the corridors that connect them will be increasingly important for protecting the rural character of our towns.

We want to thank all our Sedgwick supporters for being our partners in this work. In 2024, the Trust voluntarily paid \$3,968 in real estate taxes to the town and a total of \$24,603 to all the towns in which we hold land.

We are looking forward to another great year in 2025 and hope to see many of you out enjoying the land and water.

### *Report on the Audit of the Financial Statements*

#### *Opinions*

We have audited the accompanying financial statements of the governmental activities, each major fund and the aggregate remaining fund information of the Town of Sedgwick, Maine as of and for the fiscal year ended June 30, 2024, which collectively comprise the Town's basic financial statements as listed in the table of contents, including the related notes to the financial statements.

In our opinion, the financial statements referred to above present fairly, in all material respects, the respective financial position of the governmental activities, each major fund and the aggregate remaining fund information of the Town of Sedgwick, Maine, as of June 30, 2024, and the respective changes in financial position thereof for the fiscal year then ended in accordance with accounting principles generally accepted in the United States of America.

#### *Basis for Opinions*

We conducted our audit in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Town of Sedgwick, Maine, and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinions.

#### *Responsibilities of Management for the Financial Statements*

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America; this includes the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Town of Sedgwick, Maine's ability to continue as a going concern for twelve months beyond the financial statement date, including any currently known information that may raise substantial doubt shortly thereafter.

#### *Auditor's Responsibility for the Audit of the Financial Statements*

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinions. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Town's internal control. Accordingly, no such opinion is expressed.

**Required Supplementary Information**

Accounting principles generally accepted in the United States of America require that the management's discussion and analysis, budgetary comparison information, pension and other post-employment benefits disclosure schedules on pages 3 through 6 and 26 through 32 be presented to supplement the basic financial statements. Such information is the responsibility of management and, although not a part of the basic financial statements, is required by the Governmental Accounting Standards Board, who considers it to be an essential part of financial reporting for placing the basic financial statements in an appropriate operational, economic, or historical context. We have applied certain limited procedures to the required supplementary information in accordance with auditing standards generally accepted in the United States of America, which consisted of inquiries of management about the methods of preparing the information and comparing the information for consistency with management's responses to our inquiries, the basic financial statements, and other knowledge we obtained during our audit of the basic financial statements. We do not express an opinion or provide any assurance on the information because the limited procedures do not provide us with sufficient evidence to express an opinion or provide any assurance.

**Supplementary Information**

Our audit was conducted for the purpose of forming opinions on the financial statements that collectively comprise the Town's financial statements as a whole. The supplementary information and the schedule of expenditures of federal awards are presented for purposes of additional analysis and is not a required part of the financial statements. The supplementary information and the schedule of expenditures of federal awards are the responsibility of management and were derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The schedule of expenditures of federal awards is presented for purposes of additional analysis as required by the State of Maine Department of Education.

The information has been subjected to the auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with auditing standards generally accepted in the United States of America. In our opinion, the information is fairly stated in all material respects in relation to the financial statements as a whole.

A copy of this ordinance is available for public inspection at the Town Office during normal office hours. Also available for inspection is a copy of the state's General Assistance Statutes, as copies of the state law are made available to the municipality by the Maine Department of Human Services.

Persons who wish to apply for General Assistance may do so at the Town Office on the following days and times during normal office hours: Monday, Tuesday and Wednesday 9:00 a.m. – 3:00 p.m.; Thursday 9:00 a.m. – 5:30 p.m.; and Friday 9:00 a.m. – 1:00 p.m.

Calling ahead for an appointment is encouraged: (207) 359-2275. In an emergency and after hours, applicants may contact the Hancock County Sheriff at (207) 667-7575.

The municipality's General Assistance administrator must issue a written decision regarding eligibility to all applicants within 24 hours of receiving a signed application.
